Appearance:	A dark brown, oval, biconvex tablet with a speckled appearance. Optionally one face can be impressed with the letters 'FF'.

Nominal Menthol Content (% w/w):	0.310
Identification of Menthol :	The retention time of the peak due to menthol in the sample should be similar to the corresponding peak obtained in the standard.

2. Storage Conditions



7. Raw Material Origin

Fisherman's Friend Sugar Free Salmiak Flavour Lozenges, manufactured by Lofthouse of Fleetwood Limited contain raw materials and processing aids from plant and vegetable source only.

The raw materials and processing aids are of non-bovine origin (all fats and related products are also derived solely from vegetable sources) and consequently Fisherman's Friend products do not pose any risk of BSE/TSE or other related diseases.
