strawberries (29%), water, whipped cream (MILK) (14%), glucose-fructose syrup, sugar, WHEAT flour, whole EGG, HAZELNUTS (3%), palm fat, skimmed MILK powder, gelatine, dextrose, WHEAT starch, modified starch, rapeseed oil, acid E330, thickener E412, colouring foods (safflower extract, black carrot juice concentrate, concentrated sour cherry juice, carrot juice concentrate, pumpkin juice concentrate, apple-concentrate), raising agents (E450, E500), sweet whey powder (MILK), natural flavourings, stabiliser E440, emulsifier E471, humectant E420, apricot juice concentrate, table salt, acidity regulators (E327, E332, E330).
