11 – 14 = Military Time [14:53]

**We do put line designation on the cases i.e. S1B1 (Line S1 packaging leg B1) and on the cup we put line designation and product descriptor i.e. S1BCC (Line S1, B side packaging – CC = Product descriptor for Chocolate)

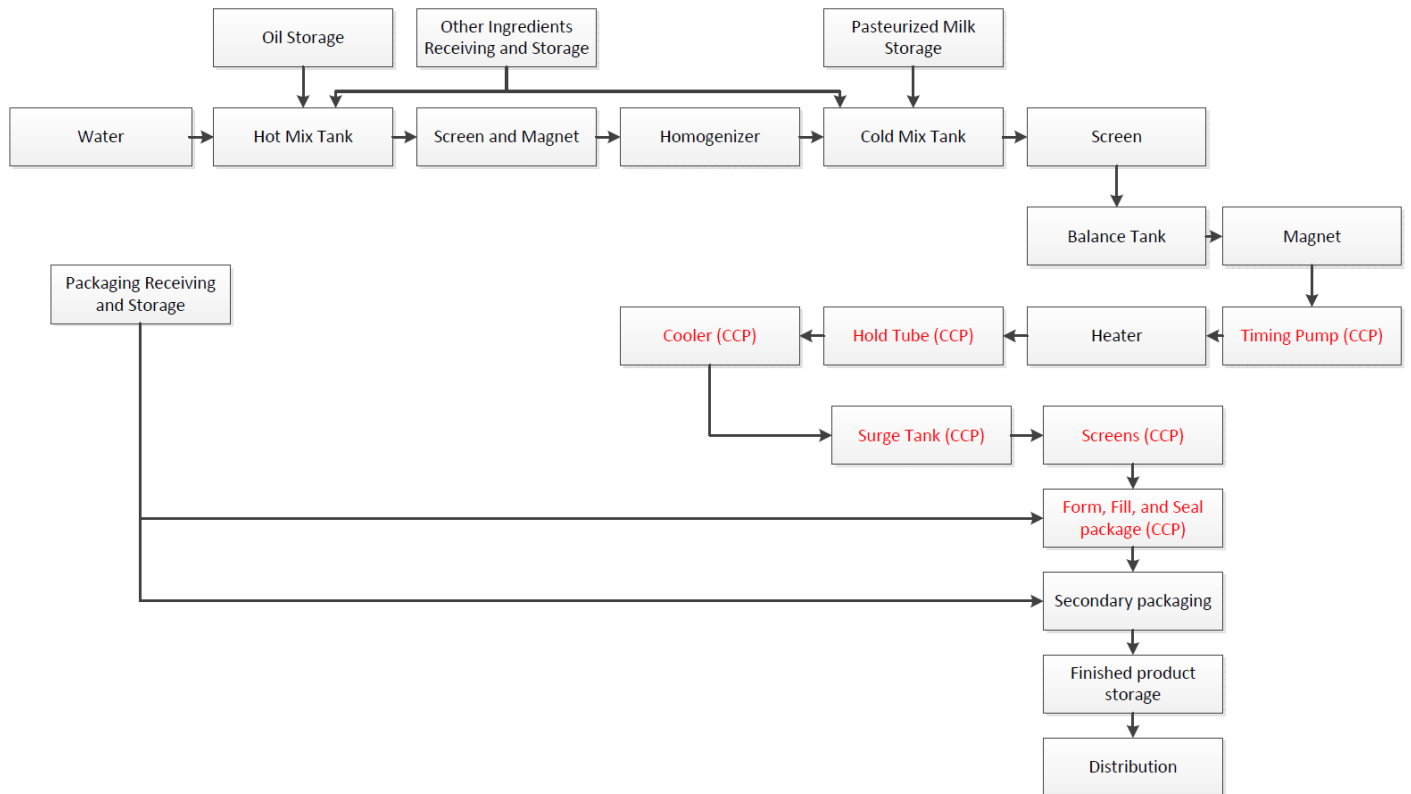
